THE DISTRICT/GROUP IS RESPONSIBLE FOR THE PROVISION OF MEALS.

THE DEADLINE FOR RETURN OF *CONTINGENT BOOKING FORMS* AND DEPOSITS IS **FRIDAY 22ND JANUARY 2010**.

PLEASE COULD YOU TRY AND ARRANGE FOR A SINGLE CHEQUE TO COVER YOUR BOOKING.

CHEQUES ARE TO BE MADE PAYABLE TO "WYCSC"

THE *PARENTAL CONSENT FORM* (WILL BE SUPPLIED WITH CONFIRMATION OF RECEIPT OF BOOKING) NEEDS TO BE COPIED, AS REQUIRED, AND AUTHORISED BY PARENT / GUARDIAN – TWO COPIES OF THE COMPLETED FORMS MUST BE BROUGHT TO THE EVENT. **IMPORTANT – NO SCOUT WILL BE ALLOWED TO PARTICIPATE WITHOUT A COMPLETED FORM.**

CONTINGENT EQUIPMENT

IT IS THE RESPONSIBILITY OF THE CONTINGENT LEADER TO ENSURE THAT PARTICIPANTS IN THEIR CARE ARE PROVIDED AN APPROPRIATE LIST OF PERSONAL EQUIPMENT REQUIRED.

THE EVENT ORGANISERS WILL PROVIDE TOILET/WASH FACILITIES AND SHELTER FOR ACTIVITIES WHERE APPROPRIATE.

PLEASE INFORM PARTICIPANTS THAT ARRIVAL AND DEPARTURE FROM SITE REQUIRES THE WEARING OF UNIFORM, AND NECKERS MUST BE WORN DURING THE WEEKEND (UNLESS REMOVED FOR ACTIVITY SAFETY REASONS).

PLEASE NOTE THAT THE ORGANISERS CANNOT BE HELD RESPONSIBLE FOR DAMAGE OR LOSS TO ANY EQUIPMENT BROUGHT TO THE EVENT – PLEASE ENSURE THAT ADEQUATE INSURANCE COVER IS IN PLACE.

HOME CONTACT & NIGHTS AWAY NOTIFICATION

PLEASE ENSURE THAT YOU HAVE FOLLOWED THE RULES AND GUIDELINES LAID OUT IN P.O.R. WITH REGARDS TO HOME CONTACTS AND NOTIFICATION OF NIGHTS AWAY TO YOUR DC.

ARRIVAL AT EVENT

DUE TO THE NUMBER OF VEHICLES ARRIVING AND LEAVING THE SITE, MARSHALLS WILL BE ON DUTY TO RELIEVE ANY CONGESTION AND TO OVERSEE PARKING.

ANY VEHICLES BEING USED TO TRANSPORT EQUIPMENT TO CAMPING AREAS MUST BE REMOVED BY THE TIME STATED IN THE TIMETABLE FOR THE EVENT.

IT IS THE DECISION ON THE TROOP LEADERS REGARDING THE ARRIVAL TIME OF THEIR SCOUTS ON THE SATURDAY MORNING – NO SCOUTS ARE PERMITTED TO STAY OVERNIGHT ON FRIDAY.

MEDICATION

ALL MEDICATION FOR PARTICIPANTS MUST BE STORED IN A CONTAINER AND CLEARLY MARKED WITH THE NAME AND DOSAGE INFORMATION OF THE RECIPIENT.

THE CONTINGENT LEADER IS RESPONSIBLE FOR THE SAFE KEEPING AND ADMINISTERING OF ANY MEDICATION REQUIRED BY PARTICIPANTS.

ACCOMMODATION

CAMPING AREAS WILL BE DESIGNATED ON ARRIVAL – IF YOU WISH TO REQUEST A SPECIFIC AREA THEN PLEASE CONTACT THE COUNTY OFFICE WITH DETAILS.

NO GUARANTEE CAN BE MADE THAT REQUESTS WILL BE FULFILLED, BUT EVERY EFFORT WILL BE MADE TO ASSIST.

CONTINGENT LEADERS WISHING TO SET UP PRIOR TO THE EVENT ARE ASKED TO CONTACT DAVID "GILLY" GILL TO ARRANGE MATTERS FURTHER.

LOST PROPERTY

IT IS ESSENTIAL THAT CONTINGENT LEADERS ADVISE PARTICIPANTS TO TAKE CARE OF THEIR BELONGINGS DURING THE EVENT.

PROGRAMME

DETAILS OF THE EVENT PROGRAMME WILL BE AVAILABLE IN ADVANCE OF THE EVENT.

AT LEAST ONE LEADER FROM EACH CONTINGENT WILL BE REQUIRED TO HELP WITH THE CAMP CHALLENGE ON SUNDAY.

DEPARTURE FROM EVENT

TO AVOID ACCIDENTS AND REDUCTION IN ENJOYMENT BY PARTICIPANTS, CONTINGENT LEADERS ARE REQUESTED TO AVOID TRANSPORTING OF EQUIPMENT FROM SITE TO VEHICLES BEFORE THE CLOSING CEREMONY.

IN ADDITION, PARTICIPANTS MUST BE ALLOWED TO CONTINUE TAKING PART UNTIL THE EVENT IS OFFICIALLY CLOSED.

THE MOVEMENT OF VEHICLES ON SITE, ESPECIALLY PRIOR TO 1PM ON SUNDAY, WILL BE RESTRICTED.
